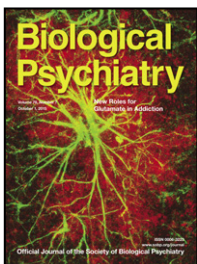

Confocal microscopy conducted by Scofield *et al.*, as depicted on the cover (Figure 1D, pages 441-451 in this issue), revealed astrocyte-specific expression of Gq-DREADD via co-labeling of GFAP (green) with viral anti-hemagglutinin staining (red). Overall, the authors found that Gq-DREADD mediates the release of glial glutamate, which in turn, inhibits reinstatement of cocaine seeking.
